# WEDNESDAY NIGHT POKER 5X BONUS POINT PROMOTION

(4 bonus Points per each 1 base point)

## Method of Entry:

- 1. Entry into the promotion is exclusive to all current Players Club members who play poker cash games at Christchurch Casinos Limited anytime during the Promotional Period and Times.
- 2. The promotion is exclusive to all Cash poker table games.
- 3. All current Players Club members who register for the poker cash games, by showing their Players Club card to the appropriate poker table game's employee or poker supervisor, are eligible to enter the promotion.
